Author Guidelines for the Preparation and Submission of the Extended Abstract

All submitted extended abstracts should report original and previously unpublished research results. The language of the manuscript would be English (Use American or British standards, but not a mixture of both). All Non-English terms and technical terms should be italicized. All abbreviations should be written in full at the first time of appearance. SI units should be used.

Please send your Extended Abstract via email address isa2023@esn.ac.lk and mention ‘Extended Abstract submission’ in the subject line.

Manuscript Format

- i. The length of the paper should not exceed 5 pages including tables, figures, references and appendices.
- ii. Articles should be typed in single-space.
- iii. Margins (left, right, top and bottom) should be 2.5 cm.
- iv. Text should be justified, except for the article title and block quotations.
- v. Text should be- font: Times New Roman; size: 12, except for the heading.
- vi. All pages should be numbered sequentially using Arabic numerals at the bottom center.
- vii. Tables or charts must be in MS Excel compatible format.
- viii. Submit your paper as an electronic file written in a Microsoft Word document (DOC, DOCX).

Abstract (Times New Roman, 13, Bold, Capitalize Each Word)

The abstract should be a single paragraph, consists of 250 to 300 words. It should clearly state the purpose of the work, the procedures used to execute the work, and major findings with citation-free.

Keywords: 5-6, Times New Roman, 10 font size

Introduction (Times New Roman, 13, Bold, Capitalize Each Word)

State the objectives of the work and provide an adequate background, avoiding a detailed literature survey or a summary of the results.

Materials and Methods (Times New Roman, 13, Bold, Capitalize Each Word)

Provide sufficient details about the methods you used to carryout the research. Materials already published should be indicated by a reference: only relevant modifications should be described.

Sub-Title (Times New Roman, 12, Italic)

It should be described with sufficient detail of the contents.

Results and Discussion (Times New Roman, 13, Bold, Capitalize Each Word)

Results should be clear and concise. This should explore the significance of the results of the work and should not contain extensive repetition of the results. The findings should be discussed in relation to previously published work. Avoid extensive citations and discussion of published literature.

Conclusions (Times New Roman, 13, Bold, Capitalize Each Word)

The main conclusions of the study must be presented in a short Conclusions section, which may stand alone or form a subsection of a Discussion or Results and Discussion section.

Acknowledgments (Times New Roman, 13, Bold, Capitalize Each Word)

All acknowledgments (if any) should be included at the very end of the paper before the references and may include supporting grants, presentations, and so forth.

Reference (Times New Roman, 13, Bold, Capitalize Each Word)

Reference should be prepared using Harvard-style.

Tables and Figures (Times New Roman, 12, Bold, Capitalize Each World)

Present tables and figures at the appropriate place within text, not at the end of the article.

Tables should be numbered sequentially using Arabic numbers.

The titles should be self-explanatory and placed above the Tables.

Tables should not contain any vertical lines.

Figures should be numbered sequentially using Arabic numbers and be accompanied with a self-explanatory caption placed below the Figure.
